

#### Advocacy - Cole Eason, JD

Throughout the year, we have engaged with The National Association of Charitable Gift Planners (CGP) to advocate for our members and promote charitable gift and tax policies favorable to donors. After new major tax legislation is passed there is customarily some fine-tuning, however, congressional priorities in 2020 did not favor revisions to the SECURE Act or the CARES Act. A more generous Uniform Charitable Deduction (UCD) remains a primary legislative goal for the non-profit community and, since this appears to have bipartisan support now, we anticipate a big push for this in the next Congress.

#### Building Blocks - Donna C. Watson, JD

Our Building Blocks Committee pivoted and delivered MACGP's first virtual all-day conference with 148 registered attendees. The 25th Annual Building Blocks event included 7 presenters, including keynote speaker, Dr. Russell James, III. The Conference also included a panel of local professionals discussing the impact of COVID-19 on nonprofits, social and networking time for attendees, CFRE and CLE credits.

#### Sponsorship - Bill Riek, CFRE


